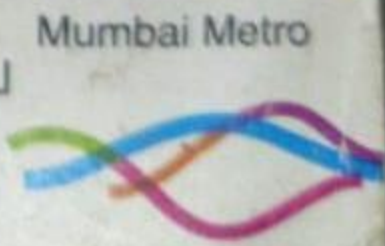




17. **Liability:** You will be personally liable for any act of willful and intentional loss, damage or harm to the company, its clients and its employees.


